Congratulations on being chosen to participate in Camp NAWIC Ventura County. In order for the program to run efficiently, it is important that you adhere to the following guidelines.

### Current student picture ID

- In order to identify students in program, you must present a **current** picture ID. Without a current ID you will not be allowed on campus.

### Appropriate Clothing

- We will be visiting outside demo sites around the facility. Girls please wear long pants and full length tee shirts. No jewelry should be worn by girls while in camp. Also, flat, closed-toe shoes is required for safety purposes.

### Behavior While At Camp

- All electronic devices will be turned off prior to entering the classroom.
- Each class is conducted in a business setting. All students are expected to remain in the classroom for the duration of each class. Appropriate behavior is expected. There will be no horseplay to or from the classroom. Any student who is found to be disruptive during class will be removed and escorted out of campus to wait for their parent or guardian. The student will then be removed from the program.
- After first absence a student will be removed from the program.

- Pictures will be taken of students during the week for reporting purposes and future programs.
